3) This Agreement shall be valid until 31st December 2017 for the carriage on the territories of those ADR Contracting States signatory to this Agreement. If it is revoked before that date by one of the signatories, it shall remain valid until the above mentioned date only for carriage on the territories of those ADR Contracting States signatory to this Agreement which have not revoked it.
